

Online Sweepstakes Rules

1. Introduction

Informa LLC, d/b/a *Electrical Construction & Maintenance, Contractor, and Contracting Business* have created an online program called Contracting Technology Bootcamp, which resides at the web site www.contractingbootcamp.com. Informa is conducting an Online Sweepstakes (“Sweepstakes”) associated with the Contracting Technology Bootcamp. NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.

2. Eligibility

Entrant must be a legal resident of the fifty (50) United States and the District of Columbia, who is 18 or older as of August 1, 2019 (“Entrants”). Employees of Informa LLC, their respective parents, subsidiaries, affiliates, advertising and promotion agencies and their family/household members (defined as parents, spouse, children, siblings, grandparents) are not eligible to enter. Void outside the fifty United States and the District of Columbia, and where prohibited, taxed, or restricted by law. All federal, state and/or local rules and regulations apply.

3. Start/End Dates

Sweepstakes begins at 12:00:01 a.m. P.T. on August 1, 2019 and ends at 11:59:59 p.m. P.T. on August 31, 2019 (the “Sweepstakes Period”).

4. How to Enter

Visit <http://www.contractingbootcamp.com>, navigate to the “Register” page on the site, and fill in the required entry information. Eligibility for the Weekly Prize requires viewing at least one piece of content on the web site that require registration for viewing, during the prior 7 calendar days before the weekly drawing each Monday (12:00 AM Monday - 11:59 PM Sunday). Eligibility for Grand Prize is based upon viewing at least one piece of content on the web site that requires registration during the month of August 2019. Entrants must accurately provide all required contact information. Limit one entry per person, per email address. More than one entry from any person or e-mail address will void all entries from that person or e-mail address. Entrants must provide a valid business email address associated with the company they work for. All entries must be received during the Sweepstakes Period. Informa is the official timekeeper for the Sweepstakes, of which all decisions are final. No automated entry devices and/or programs permitted. bugs or malfunctions, that Entrants may encounter when submitting an entry or participating in the Sweepstakes. Proof of submission will not be deemed to be proof of receipt by Informa.

5. Drawing

One winner will be selected in a random drawing each Monday in August 2019, from all eligible entries received during the prior week. One Grand Prize winner will be selected in a random drawing on or about September 1, 2019. Winners will be selected by Informa, whose decisions are final and binding in all matters relating to the Sweepstakes. Odds of winning depend on the number of eligible entries received. Potential winner(s) will be notified by e-mail each Monday (for the Weekly Prize) and on or about September 3, 2019 (for the Grand Prize). The entrant selected as a potential winner must comply with all terms and conditions set forth in these Official Rules, and winning is contingent upon fulfilling all such requirements.

6. Prizes

Upon prize forfeiture, no compensation will be given. Limit one prize per person.
